ACCOMPLISHMENTS

Fiscal year 2017 was a year of great progress for Florida Parishes Human Services Authority as we continued our efforts to evolve the agency into an organization that can thrive in the current environment serving residents of Livingston, St. Helena, Tangipahoa, St. Tammany, and Washington parishes in need of behavioral health or developmental disabilities services. As the leader of this organization I am very proud of what we've achieved but, more importantly, I am excited for the future of FPHSA as our transformation continues. I know that the hard work and caring that our staff display each and every day makes a significant difference in the lives of those we serve as we continue to light their paths forward into health and wellness.

- The agency finished the fiscal year under budget and increased collections allowing for a deposit of funds into the escrow account.
- The agency was able to absorb three different midyear cuts without making any reductions to services or laying off any staff members by managing existing vacancies and expenditures responsibly along with increases in collections.
- Contracted with additional third party insurers to allow for billable services to be provided to more of those in need of care across the catchment area.
- Implemented improved billing and front desk procedures to increase collections on services provided including those associated with client billing as appropriate.
- Completed the Request for Services Registry project which screened individuals awaiting developmental disability waiver services across the district having screened a higher percentage of individuals on the registry than all but one other LGE.
- Brought all developmental disabilities participants' statements of approval current.
- Successfully passed the triennial CARF accreditation resurvey in January 2017.
- Scored over 97% compliance rating on the Civil Service audit of the Human Resources Department indicating that FPHSA is doing an outstanding job at ensuring state resources as related to employees and related costs are handled appropriately.

ACCOMPLISHMENTS

- Successfully completed the annual AIP audit in March which evaluates compliance with block grant requirements as established by the federal government.
- Scored a 96% on the annual risk management audit which indicates that our policies and procedures are effective at ensuring staff, client, and visitor safety while also safeguarding state property. Positive scores on these audits also qualify for lower rates for risk management premiums.
- Improved employee retention and recruitment by 50% from over 40 vacancies to approximately 20.
- Purchased computer hardware and software to replace outdated and out of warranty equipment as we continue to explore opportunities to improve the client experience and staff effectiveness through the use of technology.
- Established a new, modern website for the agency to enhance visibility in the community, provide more timely information on services available, and provide a conduit to contact the agency with questions or requests for services.
- Created a social media presence to communicate both within the agency and externally to clients and other stakeholders using Constant Contact and Facebook.
- Increased the presence of the agency in the community by participating in projects such as Safe Haven, Prisoner Reentry Initiative, and the One Mind Campaign.
- Introduced Medically Assisted Treatment as an option for individuals with opioid use disorders and contracted with the 22nd Judicial District Court's specialty courts programs to improve outcomes for opioid addicted individuals in their programs.
- Improved and expanded relationships with legislators, law enforcement agencies, and judiciaries within the Florida Parishes to ensure that resources are pooled to achieve our common goals of serving behavioral health needs within the community.
- Initiated a new process with Livingston Parish Jail to provide behavioral health services to their inmates vis telemedicine reducing safety risks and costs associate with transporting prisoners to the clinic.
- Applied through the Office of Behavioral health to secure grant funding for grants related to opioid treatment and training focused on treatment for youth with cooccurring behavioral health and developmental disabilities concerns.

ACCOMPLISHMENTS

- Worked with Facility Planning and Control to improve the environment of Mandeville Behavioral Health Clinic, including a long overdue replacement of the roof, as well as ongoing work to renovate the flood damaged Bogalusa clinic.
- Took initial steps to establish a full-time clinic in Denham Springs to better serve the Livingston Parish population.
- Introduced measures to establish a primary care presence within the behavioral health clinics.
- Redesigned behavioral health modes of treatment to use contemporary evidence based practices with better outcomes and provided certified training for staff tasked with providing them.
- Had a staff member trained in Asist suicide training and provided a community training on the topic.
- Improved the culture of the agency by modeling a servant leadership model and refocusing attention on the agency's mission to serve others.
- Hosted employee meetings at each location to discuss vision for the agency and hear employee feedback.
- Established an Employee Relations Committee to identify opportunities to recognize staff and improve morale.
- Implemented quarterly all employee forums to improve communication of issues across all sites in the agency.
- Improved the overall morale and of FPHSA both internally and externally so that staff are prouder and happier to be a part of the agency and that external organizations desire to work with us as a partner in providing behavioral health and developmental disabilities services in the community.

FPHSA HISTORY/LEGISLATION

FPHSA was established during the 2003 Louisiana Legislative session under House Bill 954. Upon passage by the Legislature, House Bill 954 became Act 594 of the 2003 Legislative session.

Effective July 1, 2004, Florida Parishes Human Services Authority (FPHSA) became operational as a local governance entity. FPHSA was created to manage funding dollars in the areas of addictive disorders, developmental disabilities, and mental health services and to bring spending and operational decisions down to the local level.

More recently, Senate Bill 58, was enacted through Act No. 73 of the 2017 Regular Session, to amend and reenact the enabling statues dealing with the Human Services Districts/Authorities, known as Local Governance Entities (LGEs), under La. R.S. 28:910 et seq.

VISION

That all people of Florida Parishes will be empowered to lead meaningful and productive lives among friends, relatives, and neighbors regardless of behavioral health needs or developmental disabilities.

MISSION

Florida Parishes Human Services Authority (FPHSA) is lighting the path forward into recovery by providing personcentered services to those with behavioral health needs and developmental disabilities so that they may reach their fullest potential in health and wellness.



PARISH POPULATIONS AS PERCENTAGE OF CATCHMENT AREA POPULATION*



CLIENTS SERVED BY PARISH OF RESIDENCE*+^





Page 12 of 53 Thirteenth Annual Report to the Board FY 2017 Addictive Disorders Services (ADS) consists of prevention services and treatment services for addictions and abuse related to alcohol, other drugs, gambling, and tobacco. Licensed counselors, in both outpatient and residential settings, assist individuals to stop using alcohol or drugs, maintain drug-free lifestyles, and develop improved social, emotional, and psychological skills.

Prevention services prepare and support individuals and systems in the creation and reinforcement of healthy behaviors and lifestyles. Alcohol, tobacco, and other drug problem prevention focuses on risk and protective factors associated with the use of these substances, concentrating on areas where research and experience suggest that success in reducing abuse and addiction is most likely. Evidence-based educational programs are currently administered to students in schools in all five parishes of the FPHSA catchment area.

All individuals are initially assessed in outpatient clinics with most individuals treated exclusively in this setting. FPHSA's outpatient clinics provide the bulk of treatment designed to address each individual's needs for lasting sobriety. Participants are also involved in 12-step recovery programs operating in community-based settings. Treatment duration for most individuals is six to nine months. Occasionally, referrals are made from FPHSA's outpatient clinics to its Level III.5 residential program, Alcohol and Drug Unit (ADU)/Fontainebleau Treatment Center (FTC), where individuals reside and participate in treatment. ADU/FTC also serves clients referred from sources throughout the state.

Permanent Supportive Housing (PSH) was designed to provide flexible, community-based supportive services linked to affordable rental housing units in community-integrated, non-institutional settings. The program serves individuals with long-term disabilities with extremely low-income who are in need of supportive services due to their disabilities. In FY 17, 205 households were served by FPHSA through Permanent Supportive Housing Services (PSHS) of which 158 households did not receive clinical services.






BEHAVIORAL HEALTH SERVICES PREVENTION EFFORTS







DEVELOPMENTAL DISABILITIES SERVICES ELIGIBILITY DETERMINATIONS BY PARISH












FPHSA EMPLOYEE SALARIES BY PARISH OF RESIDENCE

FPHSA EMPLOYEE SALARIES BY PARISH EMPLOYED








